| 3. | Essential Qualification and Experience | Persons of ability and integrity, having adequate knowledge of, and professional experience in, aviation, economics, law, commerce or consumer affairs may apply for the said post.<br><br>Further, any person who is or has been in the service of Government shall not be appointed as a Member unless such person has held the post of Secretary or Additional Secretary to the Government of India or any equivalent post in the Central or State Government for a total period of not less than 3 years.<br><br>For persons who are presently working or have retired from a Central Public Sector Undertaking or a Statutory Body, he should be working or should have retired at least as Executive Director or its equivalent in a Schedule 'A' CPSU/equivalent rank in Statutory Body.<br><br>For all other persons, they should have at least 25 years of experience in the relevant field. |
| 4. | Tenure                                 | The Member shall hold office for a term of upto five years from the date on which he enters upon his office or till he attains the age of 62 years, whichever is earlier.   |
