BROAD TERMS OF ENGAGEMENT

1. Qualification:

- (i) **Essential:** LLB from any recognised university
- (ii) **Desirable:-** 2 years experience in relevant field.
- (iii) **Other Qualities (Essential):-** working knowledge of computer, proficiency in English and he/she should be able to work for long working hours.

2. Age Limit:

Candidate should not be more than 35 years of age as on closing date of receipt of application.

3. Leave:

Young professional shall be eligible for 12 days leave in a calendar year on pro-rata basis.

4. TA/DA

No TA/DA shall be admissible for joining the assignment or on its completion. Young Professional will not be allowed foreign travel at Government expenses. However, Young Professional shall be allowed TA/DA for their travel inside the country in connection with the official work as per government rules.

5. Type of appointment:

The appointment will be purely on contract basis.

6. Contract Period:

Initial contract would be for a period of one year and shall be extended for further period of one year at a time as may be decided by the Ministry. The contract can be terminated by either party by giving one month notice in advance, at any time, without explaining the reason.
