1. COMPANY PROFILE

Pawan Hans Limited was incorporated as a company on 15th October, 1985, first took to skies on 4th October, 1986 with the objective of providing helicopter support services to meet the requirements of petroleum sector by replacing foreign operators, providing services to connect remote and operating tourist charters with the objective to provide world class port services. It is a schedule 'B' CPSE under the administrative control of Ministry of Civil Aviation.

Its registered office is in New Delhi and Corporate office is at Noida (UP).

The authorized and paid up capital of the Company is Rs.560 crores and **Rs.557.48** crores respectively as on 31st March, 2018.

The share holding by Govt. of India in PHL is 51% and ONGC is 49%.

2. JOB DESCRIPTION AND RESPONSIBILITIES:

The Chairman and Managing Director is the Chief Executive of the company and is responsible to the board of Directors and Government of India. He / She is responsible for efficient functioning of the company for achieving its corporate objectives and performance parameters.

ELIGIBILITY

- I. AGE: On the date of occurrence of vacancy
- (i) Minimum 45 years.
- (ii) Not more than 58 years for internal candidates and not more than 57 years for others.

The age of superannuation is 60 years.

II. QUALIFICATION AND EXPERIENCE:

The applicant should be a graduate from a recognized university with good academic record. He / She should possess experience of atleast 3 years in the post of GM equivalent or above in a PSU. The minimum length of experience at similar level for internal candidates is 2 years.

Persons preferably with Technical/ MBA qualifications and having experience in management and familiarity with Finance, Marketing, Production will have added advantage. Knowledge of Aviation industry is desirable. Overall work experience of 20 years and above is desirable.

The competent authority may relax any of the conditions of eligibility in deserving cases.
