

## Detailed Monthly information for the month of August, 2023

Important Policy decisions taken and major achievements during the month:

### MINISTRY OF CIVIL AVIATION

1. An MoU was signed between Government of New Zealand and Government of India relating to Air Services. India now has an open sky arrangement with New Zealand.
2. The Ministry of Civil Aviation granted permission for operation of charter flights from Afghanistan and United Arab Emirates under special circumstances.
3. One new Airport at Utkela in Odisha and four new routes commenced under Regional Connectivity Scheme in the month of August, 2023.
4. AAI Cargo Logistics and Allied Services Company Limited (AAICLAS) commissioned newly built domestic air cargo facility with Regulated Agent (RA) operations at Pune Airport on 05.08.2023.
5. Four hundred and thirty eight drones were registered and Unique Identification Number (UIN) were issued.
6. Seven hundred and thirty five Remote Pilot certificates were issued.
7. Three new Remote Pilot Training Organisations (RPTO) commenced.
8. National Air Sports Guidelines 2023 published on 31.08.2023.

## **COMMISSION OF RAILWAY SAFETY (CRS)**

- A. 12 statutory inspections of Network Expansion related work of Doubling / Multiple Lines / New Lines / Gauge Conversion for a length of 156.68 kms for Indian Railways were done by the Commissioners and authorizations issued, thus making the cumulative total of these works during the year 2023-24 to 816.57 kms.
- B. 68 Minor Works were sanctioned and 01 case of Rolling Stock has been recommended for Railway Board's sanction.
