#### MINISTRY OF CIVIL AVIATION

- 1. Rajkot International Airport, Gujarat was inaugurated by Hon'ble PM on 27.07.2023.
- Fourth Runway and Eastern Cross Taxiway (ECT) at IGI Airport, Delhi was inaugurated on 14.07.2023 by Hon'ble Minister of Civil Aviation.
- New Intergrated Terminal at Veer Sawarkar International Airport, Port Blair was inaugurated by Hon'ble PM on 21.07.2023.
- AAICLAS has commissioned Air Cargo movement through Airline Self-Handling by M/s Indigo for Outbound Air Cargo Operations at Goa airport on 12.07.2023.
