VACANCY CIRCULAR

Sub: Filling up of 01 (One) post of Senior Inspector (Technical) in the office of Commissioner of Railway Safety (CRS), Western Circle, Mumbai on deputation basis- reg.

1. Commission of Railway Safety, working under the administrative control of the Ministry of Civil Aviation, Government of India, deals with matters pertaining to safety of rail travel and train operation and is charged with certain statutory functions as laid down in the Railways Act, 1989, which are of an inspectorial, investigatory & advisory nature, invites application for filling up of 01 (One) post of Senior Inspector (Technical) in the office of Commissioner of Railway Safety, Western Circle, Mumbai on deputation basis. Post details are as under: -

Officers of the Central Government or State Governments or Union Territories or Universities or recognized research institutes or public sector undertakings or statutory or autonomous organizations, —

- (a) Holding analogous posts on regular basis in the parent Cadre or Department; or
(b) With five years' service in the grade rendered after appointment thereto on a regular basis in level-6 (Rs. 55,400-1,12,400) in the pay matrix or equivalent in the parent Cadre or Department; and possessing the educational qualifications and experience: -

(i) Bachelors Degree in Civil Engineering or Mechanical Engineering or Electrical and Electronics Engineering or Electronics and Communication Engineering or Electronics and Telecommunication Engineering from a recognized University or Institution;

OR

(ii) Diploma in Civil Engineering or Mechanical Engineering or Electrical and Electronics Engineering or Electronics and Communication Engineering or Electronics and Telecommunication Engineering from a recognized University or Institution and having two years' experience of duty in a Government Organization in the related subject.

Note 1: The period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.

Note 2: The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding fifty- Six years as on the last date of receipt of applications.



2. Applications of willing officials, fulfilling the above conditions may please be forwarded along with :-
- Bio-data (in duplicate) as in the proforma given in Annexure-A.
 - Photocopies of ACRs for the last five years duly attested on each page by an officer not below the rank of Under Secretary to the Govt. of India.
 - Vigilance Clearance Certificate.
 - Integrity Certificate.
 - A statement giving details of major/minor penalties imposed, if any during last 10 years.
3. The officials selected will be posted at Office of Commissioner of Railway Safety, Western Circle, 2nd Floor Churchgate Station Building, Annexe. MK Road, Mumbai- 400020.
4. One set of complementary Railways Pass and one set of Privilege Ticket Order of applicable class in a year will be given to the employee appointed in the Commission of Railway Safety during the period of deputation. **However, for Railway employees the normal pass rules will apply.**
5. Applications of willing officers, who fulfil the requisite qualifications and experience, may be forwarded to the **Commissioner of Railway Safety, Western Circle, 2nd Floor, Churchgate Station Building, Annexe. MK Road, Mumbai-400020 (in duplicate)** in the prescribed proforma (Annexure-A) along with all requisite enclosures through proper channel **within a period of 45 days (Forty Five days) from the date of issue of this vacancy notification**, while forwarding the application, it may also be verified and certified by the employer that the particulars furnished by the applicant (s) are correct.
6. The application may also be sent through email on dycrs@wr.railnet.gov.in duly completed in all respect through proper channel within the date. Since, these vacancies are to be filled on deputation basis, private candidates are not eligible.
7. The candidates, once selected for the post, will not be allowed to withdraw their candidature Subsequently.
8. The application received after the closing date or other than through proper channel or without ACRs and other certificates as required will not be entertained.
