#### ORDER

### Approval of 26 green zone sites for NPNT - compliant drones

- 1. With a view to facilitate operations by "No-Permission-No-Takeoff" (NPNT) compliant drones, it has been decided to permit the same at 26 green zone sites upto 400ft AGL. This is in addition to the six green zone sites approved vide AV-22011/8/2015-SD&IT dated 03 Apr 2020.
- 2. The green zones are listed in Annexure I. The green zones shall be enabled on the Digital Sky Platform (<a href="https://digitalsky.dgca.gov.in/">https://digitalsky.dgca.gov.in/</a>) soon.
- 3. Drone flights in the green zone sites shall be compliant with the applicable conditions of DGCA CAR Section 3 Series X Part I dated 27 Aug 2018.
- 4. The concerned State Governments and Local Administrations are requested to facilitate operations of NPNT-compliant drones in the said sites.
