**Subject: Constitution of Civil Aviation Advisory Group of Airlines.**

In order to provide a platform for discussion on the issues concerning Airlines and to find a solution to the issues, an advisory group consisting of airlines is constituted as follows:

(i) Hon'ble Minister of Civil Aviation	-Chairman
(ii) Hon'ble Minister of State in Civil Aviation	- Member
(iii) Secretary, Ministry of Civil Aviation	- Member
(iv) Director General of Civil Aviation	- Member
(v) Shri Rajiv Bansal, CMD, Air India	- Member
(vi) Shri Rahul Bhatia, Chairman, Indigo	- Member
(vii) Shri Ajay Singh, Chairman, SpiceJet	- Member
(viii) Shri Ness Wadia, Director, Go Air	- Member
(ix) Shri Bhaskar Bhat, Chairman, Vistara	- Member
(x) Shri Sunil Bhaskaran, CEO, Air Asia	- Member
(xi) CEO, Alliance Air	- Member

2. The Joint Secretary of DG Division will act as Convener. The Joint Secretary of DT Division will support the Group on the issues related to domestic transport.

3. The terms of reference of the Civil Aviation Advisory Group of Airlines, inter alia includes as under:-

- To advise the Government for enhancing the domestic and international connectivity.
- To advise on matters related to promotion of passenger and cargo services.
- To advise on matters related to passenger facilities during air travel.
- To advise on matters related to manpower skilling in the aviation sector.
- To advise on the matters related to development of India as a hub for passenger travel, cargo and MRO operations.
- To advise on the matters related to leasing and financing of aircraft.
- To suggest ways to safeguard the viability of airlines.
- To advise on matters related to aircraft and component manufacturing.
- To advise on regulatory issues.

4. The Advisory Group may co-opt any other expert(s), if necessary, for taking requisite advice and inputs with the permission of the Chair.

5. The Group shall have its meetings at Delhi or at any other place within India as decided by the Chair. The Group may meet as may be decided by the Chair.

6. The Group, from time to time, can set up Working Sub-Groups in focused area.
