Detailed Monthly information for the month of April, 2018

Important Policy decisions taken and major achievements during the month:

1. Ministry of Civil Aviation

- A. Passengers carried by domestic airlines during Jan-Mar, 2018 were **337.90 lakhs as against 272.79 lakhs** during the corresponding period of previous year thereby registering a growth of **23.87%**.
- B. The clarifications were issued on the queries raised by Interested Bidders on the PIM/EoI for the strategic disinvestment of Air India and its Subsidiaries. Also, a corrigendum to two clauses of PIM/EoI was issued to ease out constraints raised by Interested Bidder.
- C. A task force has been constituted for formulating a road map with implementable recommendations for Government, Industry and Research Institutions to leverage the Unmanned Aerial Vehicle (UAV) technology.
- D. Bilateral talks held between Government of India and Kingdom of Morocco on 23-24th April 2018 at New Delhi. Air Service Agreement (ASA) has been initiated and the ASA shall be provisionally effective from the date of signed MoU on 24th April 2018 between the countries.
