Detailed Monthly information for the month of September, 2017

Important Policy decisions taken and major achievements during the month:

1. Ministry of Civil Aviation

Passengers carried by domestic airlines during January-August, 2017 were **754.11 lakhs** as against **644.68 lakhs** during the corresponding period of previous year thereby registering a growth of **16.97%**.

(iv) 100 feet National Flag at Bhopal Airport was inaugurated by Chairman, AAI on 22nd September, 2017.

(v) New Campus of Indian Aviation Academy at Vasant Kunj, New Delhi was inaugurated by the Hon'ble Minister of Civil Aviation on 21st September, 2017.

- (vi) Combined meeting of BOBASIO/7, BIMT/5, ASIOACG/12 & INSPIRE/8 had been conducted successfully from 18th to 21st Sep, 2017. In these meetings 12 ICAO States have participated and deliberated on ATM/CNS coordination, safety and regional seamless air navigation issues.
- (vii) Concept level safety assessment for RNP2 ATS Routes between Delhi-Mumbai had been conducted on 27th Sep, 2017, in which about 30 stakeholders participated.
- (viii) Stage length calculation for 1500(approx.) proposed ATS routes under RCS Scheme Phase 2 had been done in last week of September, 2017. .
- (ix) AIP (S) 70/2017 ILS RWY 07 Chennai Airport published effective 12th October 2017.
- (x) AIP (S) 73/2017 ILS RWY 34 CAT II/IIIA/IIIB Amritsar Airport published effective 12th October 2017 as per commitment to MoCA.
